

Scharf Quality Value Strategy

MONTHLY COMMENTARY

- The Scharf Quality Value Strategy returned 3.08% (net of fees) for the month-ending period.
- U.S. equities rallied in Q3, as the S&P 500 forward P/E remains above the 90th percentile since 1990.
- Coinciding with OpenAl's CEO saying investors have become "overexcited about Al" in August, industry observers are questioning the ultimate return on rapidly increasing GenAl-related capital expenditures, which are expected to exceed 1% of U.S. GDP in 2025.

MARKET REVIEW

Equities rallied with Fed rate cuts, as the labor market deteriorated. Tariff uncertainty improved, but some overhang remains as the ultimate impact on trade, flows, growth, inflation, and borrowing costs is unclear.

As an indicator of prevailing sentiment, in Q3, Goldman Sachs' "Non-Profitable Tech" and UBS' "Meme stock" baskets rose +30.55% and +57.92%, respectively.

In Q3, the Russell 1000 Value Index (+5.3%) underperformed the Russell 1000 Growth Index (+10.51%). Outperformance in growth in Q3 was supported by gains in IT (S&P 500 IT: +13.19%) and Communication Services (S&P 500 Communication Services: +12.04%).

PORTFOLIO REVIEW

For the month, the Strategy returned 3.08% (net of fees), outperforming the Russell 1000 Value Index, which returned 1.49%, and trailing the S&P 500 Index, which returned 3.64%.

At the stock level, the top Q3 attribution contributors were Franco-Nevada Corp., Oracle, not owning Meta, and Occidental Petroleum. The largest detractors were Fiserv, Centene, Heineken, and Markel.

At the sector level, the leaders in Q3 were stock selection in Materials, lower allocation to Communication Services, and stock selection in Energy. The leading laggards were stock selection in Financials, Health Care, and Communication Services.

In the context of broad market concerns over both the U.S. and global growth outlook, we remain confident in the fundamental prospects of our portfolio businesses. The weighted average trailing 10-year Adjusted EPS CAGR for our holdings was +11% vs. +4% for the Russell 1000 Value and +7% for the S&P 500.

OUTLOOK

Various risks call both the U.S. economic outlook and broad equity valuations—which remain high in a historical context—into question. These include ongoing trade policy uncertainty, fiscal crowding out of private investment, and the questionable return on investment for elevated GenAl-related Capex spend among mega-cap technology companies with high index weightings. We seek to mitigate these risks by selecting companies with top-quartile low earnings volatility, sustainable growth potential, conservative balance sheets, and high favorability to historical valuation ranges.
